## **Terms and Condition**

One month is equal to 26 working days (24x7) excluding Sunday, Idle charges refer as the machine is not opperating in week days.

- 1 The schedule of rate/format in enclosed and must be completed carefully by the firm/owner before submitting the quotation. The Xerox copy of all document related to the machine must be enclosed with the sealed bid during submission.
- 2 No advance or part payment will be entertained from this office. The settlement of bill will be done only on submission of bills in monthly basis upon verification by the officer in-charge.
- 3 The rates asked for the machineries for hiring full time for the project and the cost should include running, maintenance and payment for the operator.
- 4 The hiring charges of machineries shall not be entitled during major break down idle situation.
- 5 If the periodical maintenance exceeds five (5) consecutive days, the owner should make arrangement to depute another machine to the project in order not to hamper the implementation of the project. This term also apply during major breakdowns. The payment will not be made during the repair and maintenance of
- 6 If the owners fails to depute another machine after five (5) days during maintenance or break down, a penalty of 10% per day of the total cost per month shall be levied as liquidity damage and if does not turn up for work within another five (5) days under liquidity damage, the security deposit shall be forfeited and the contract shall be cancelled and will award the work to next successful bidder.
- 7 Usually, the machine will not be used on Sunday and during government holidays. However, when used, the payment will be inclusive in the rate offered by the owner on monthly basis and will not be entitled for separate payment. The same shall be applied during night in emergency.
- 8 The rate for the hiring of machine should be for 24hrs, on duty in a day. The bidders are also requested to offer the rates for Machineries as per the price Schedule in BoQ. However the machineries shall be used for one year only.
- 9 The rate offered shall be valid for one year and in any case/reason shall not be liable for change/adjustment
- 10 Usual work time starts at 7.00AM to 5.00PM. However, in order to complete the works in time, the overtime will be done till 9.00PM. Therefore, it is obligatory to keep the machine at site to cater the above time and during emergency at night.
- 11 The owner is also responsible for repair of his or other party's machine properties or if any, incase of accidents /off-road condition etc.
- 12 It is obligatory on the part of the owner to keep the machine well maintained every time, the owner shall inform the project management in writing one week before for doing maintenance works etc.
- 13 It is obligatory on the part of intending bidder to acquaint himself/herself with the nature of work and team & conditions laid in this document before filling the rate. You may contract the concerned office for further clarification.
- 14 The contractor's tax etc shall be recovered from the contractor's bill as per rules laid down by the Government from time to time.

- 15 The selected bidder should hand over the machine with operator within one week after receiving of letter of acceptance failing of which will result in cancellation of work order and forfeiture of earnest money.
- 16 The Project Manager, Dzong Construction Project Sarpang and Department of Culture will inspect and approve the machine to be used. The Project Management has the right to reject the machine at any time if found unsatisfactory for use.
- 17 The rates asked for the machineries for hiring full time.
- 18 Any terms and condition not covered herein shall be governed by the financial manual of the RGOB.
- 19 After expiry of contract agreement, a fresh contract will be floated or if agreed by the parties, the agreement based on same rates may renewed from time to time.
